

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **PROVINCIAL TREASURY OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. **2020-0778**; re; **Procurement of Delivery Receipts for the Stockyard Project, by the Provincial Treasury Office, New Capitol Compound, Tagbilaran City**, with an ABC of **P 58,000.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **ST. JUDE PRESS MARKETING AND SUPPLIES** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;




