**WHEREAS**, **GCMG CONSTRUCTION** as the 2<sup>nd</sup> Lowest Calculated Bid as Read was recommended for Post Qualification;

**WHEREAS**, upon the conduct of post qualification by the technical Working Group, **GCMG CONSTRUCTION** met the required legal, technical and financial requirements for the said project;

**WHEREAS**, upon recommendation by the Technical Working Group and after verification, validation and ascertaining of all statements made and documents submitted by **GCMG CONSTRUCTION** Bidder declared as the 2<sup>nd</sup> **Lowest Calculated Bid**, successfully passed the Post Qualification Process, thus the Committee now considered its bid as the **Lowest Complying and Responsive Bid** for the said project;
