



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **PROVINCIAL YOUTH & SPORTS DEVELOPMENT OFFICE**, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. **2020-0206**, re; **Procurement of Medals, Trophies & Other Supplies to be used for the Conduct of Boholympics 2020, by the Provincial Youth & Sports Development Office, New Capitol Compound, Tagbilaran City.** with an ABC of **P 448,950.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **ADS & PRINTS REPUBLIC** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
