WHEREAS, the <u>PROVINCIAL MOTOR POOL OFFICE</u>, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2020-0574</u>; re; <u>Procurement of Acrylic Plastic Build-up with LED Lighting Fabrication and Installation Two (2) logo and Stainless Build-up Letters Only Non-Lighted for use in the <u>Office Signage</u>, <u>Provincial Motor Pool Office</u>, <u>New Bohol Provincial Capitol Compound</u>, <u>Cogon District</u>, <u>Tagbilaran City</u> with an ABC of <u>P 89,600.00</u>;</u>

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that ADS & PRINTS REPUBLIQ offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>ADS & PRINTS REPUBLIQ</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>ADS & PRINTS REPUBLIQ</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:
