WHEREAS, the PROVINCIAL MOTOR POOL OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0574; re; Procurement of Acrylic Plastic Build-up with LED Lighting Fabrication and Installation Two (2) logo and Stainless Build-up Letters Only Non-Lighted for use in the Office Signage, Provincial Motor Pool Office, New Bohol Provincial Capitol Compound, Cogon District, Tagbilaran City with an ABC of P 89,600.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that ADS & PRINTS REPUBLIC offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
