



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **GOVERNOR'S OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. 2020-0524; re; Procurement of Diesel & Unleaded Fuel of the Various Community Development Program Activities, by the Governor's Office, New Capitol Compound, Tagbilaran City, with an ABC of P 155,000.00;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:




