BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

## RESOLUTION NO. 20-0821 Series of 2020

WHEREAS, the GOVERNOR'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0524; \*\*(e); Procurement of Diesel & Unleaded Fuel of the Various Community Development Program Activities, by the Governor's Office; New Capitol Compound, Tagbilaran City. with an ABC of P 155,200.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>BOHOL PROVINCIAL</u> <u>EMPLOYEES MPC</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>BOHOL PROVINCIAL EMPLOYEES MPC</u>including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>BOHOL PROVINCIAL EMPLOYEES MPC</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- b.) To recommend award to <u>BOHOL PROVINCIAL EMPLOYEES MPC</u> for the delivery of goods/services under Negotiated Canvass No. <u>2020-0398</u> in the amount of <u>P 147,266.00</u>;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
