WHEREAS, the OFFICE OF THE SP-BOARD MEMBER ALDNER R. DAMALERIO of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0619; re; Procurement of Various Office Supplies, Air Fresher, Alcohol, Glass Cleaner and Ink Cartridges for use at the Office of BM Aldner R. Damalerio, New Capitol Building, New Capitol Site, Tagbilaran City, Bohol with an ABC of P 76,414.40;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that ST. JUDE PRESS MARKETING AND SUPPLIES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;




