WHEREAS, the **PROVINCIAL HEALTH OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. **2020-278**; re; **Procurement of I. T Equipment for use of Provincial Containerized PCR Laboratory by the Provincial Health Office, New Capitol, Tagbilaran City** with an ABC of **P 110,000.00**;



NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:






