



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. - PHO - 2020 - 234 re: **PROCUREMENT OF I.T. EQUIPMENT** ABC of **P 56,506.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **GOLDEN AI TRADING** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **GOLDEN AI TRADING** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **GOLDEN AI TRADING** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:

- a.) To declare **GOLDEN AI TRADING** as the bidder with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** in the amount **P 54,994.00** for the **DELIVERY OF GOODS/SERVICES** under Negotiated Canvass No. - PHO - 2020 - 175;

To recommend award to **GOLDEN AI TRADING** for items no. 1 & 2 in the amount of **FIFTY FOUR THOUSAND NINE HUNDRED NINETY FOUR PESOS ONLY (P 54,994.00)** for the delivery of goods under Negotiated Canvass No. - PHO - 2020 - 175; while item no. 3 having no quotation from the supplier is for petty cash.
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings
