WHEREAS, the <u>BOHOL PROVINCIAL LIBRARY & INFORMATION CENTER</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2020-0665</u>; re; <u>Procurement of Various Office & Janitorial Supplies for use at Bohol Provincial Library & Information Center, Capitol Compound, Tagbilaran City.</u> with an ABC of P 60,867.20;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>ST. JUDE PRESS</u>
