WHEREAS, the **PROVINCIAL ENGINEER'S OFFICE** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. **2020-0532.1; Procurement of Various Spare Parts, Engine Oil with Labor for the Service Vehicle Mitsubishi Strada with Plate # 7C-CL-005 by the Provincial Engineer's Office, New Capitol Compound, Tagbilaran City.** with an ABC of **P 370,059.00;**


