BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

## RESOLUTION NO. 20-0798 Series of 2020

WHEREAS, the <u>PROVINCIAL ENGINEER'S OFFICE</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2020-0532</u>, <u>Procurement of Various Spare Parts</u>, Engine Oil with Labor for the Service <u>Vehicle Mitsubishi Strada with Plate # 7C-CL-005 by the Provincial Engineer's Office</u>, <u>New Capitol Compound</u>, <u>Tagbilaran City</u>. with an ABC of <u>P 370,059.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>TAGBILARAN CITY</u> <u>TYRE SALES & SERVICE CENTER</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>TAGBILARAN CITY TYRE SALES & SERVICE CENTER</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>TAGBILARAN CITY TYRE SALES & SERVICE CENTER</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare <u>TAGBILARAN CITY TYRE SALES & SERVICE CENTER</u> as the bidder with the <u>LOWEST CALCULATED AND RESPONSIVE BID</u> for the <u>DELIVERY OF GOODS/SERVICES</u> under Negotiated Canvass No. <u>2020-0404</u>;
- b.) To recommend award to <u>TAGBILARAN CITY TYRE SALES & SERVICE CENTER</u> for the delivery of goods/services under Negotiated Canvass No. <u>2020-0404</u> in the amount of <u>P 369,893.00</u>;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
