WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 19-1035 series of 2019 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the OFFICE OF THE PROVINCIAL AGRICULTURIST in undertaking Procurement Request under PR No. 2019-0898 re: Procurement of Seaweed Seedlings: Cotonii & Spinossum for the Establishment of Provincial Seaweeds Nursery Project of the Office of the Provincial Agriculturist, New Capitol Compound, Tagbilaran City. with an ABC of P 506,500.00
