



**BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval**

WHEREAS, the CATIGBIAN DISTRICT HOSPITAL, CATIGBIAN, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2020 - 294 re: PROCUREMENT OF DESKTOP COMPUTER & 3 IN 1 PRINTER with an ABC of P 90,000.00;
