



**BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval**

WHEREAS, the OFFICE OF THE VICE-GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0541; re: Procurement of Vehicle Repair, Maintenance, Repainting & Purchase of Vehicle Spare Parts for the Service Vehicle Mitsubishi Strada under the Office of the Vice Governor, New Capitol Compound, Tagbilaran City, with an ABC of P 146,846.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that 200M AUTO REPAIR SHOP & PARTS offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;


