WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST- AGRIBUSINESS DIVISION, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0706; re; Procurement of DSLR Camera, Wireless Microphone, Rechargeable Batteries, Card Reader & 128GB Memory Card for use at Office of the Provincial Agriculturist- Agribusiness Division, New Capitol Compound, Tagbilaran City. Bohol. with an ABC of P 78,540.00;
