WHEREAS, the **BOHOL INVESTMENT PROMOTION CENTER**, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0145; re; Procurement of Printing Services for the Production of Printed IP Promotional Collaterals (2020 Edition) of the Bohol Investment Promotion Center, Capitol Complex, Tagbilaran City. with an ABC of P 149,600.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **ADS & PRINTS REPUBLIQ** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:


