WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 2019-0828 series of 2019 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **OFFICE OF THE PROVINCIAL VETERINARIAN** in undertaking Procurement Request under PR No. 2019-0487 re: **Procurement of Veterinary Supplies for the use at Office of the Provincial Veterinarian, Tagbilaran City**, with an ABC of ₱ 50,700.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **CEBU FAR EASTERN DRUG INC.**, offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;
