BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

RESOLUTION NO. <u>10-6785</u> Series of 2020

WHEREAS, the OFFICE OF THE VICE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0603; 1e; Procurement for the Installation of Slim Type Floor Mounted Air Conditioning Unit for the Office of the Vice Governor, New Capitol Compound, Tagbilaran City. with an ABC of P 205,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>SAMMY'S</u> <u>AIRCONDITIONING</u> & <u>REF. SERVICES AND REPAIR SHOP</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>SAMMY'S AIRCONDITIONING</u> & <u>REF. SERVICES AND REPAIR SHOP</u> ncluding the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>SAMMY'S AIRCONDITIONING</u> & <u>REF. SERVICES AND REPAIR SHOP</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare <u>SAMMY'S AIRCONDITIONING & REF. SERVICES AND REPAIR SHOP</u> as the bidder with the <u>LOWEST CALCULATED AND RESPONSIVE BID</u> for the <u>DELIVERY OF GOODS/SERVICES</u> under Negotiated Canvass No. <u>2020-0456</u>;
- b.) To recommend award to <u>SAMMY'S AIRCONDITIONING</u> & <u>REF. SERVICES AND REPAIR SHOP</u> for the delivery of goods/services under Negotiated Canvass No. <u>2020-0456</u> in the amount of <u>P 204,950.00</u>;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
