BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the GOVERNOR'S OFFICE – SPECIAL PROJECTS SECTION of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2020-C-206** re: PROCUREMENT OF ACCOMMODATION AND CATERING SERVICES FOR THE VISITING DIGNITARIES DURING THE CONSULTATIVE MEETINGS WITH PGBH OFFICIALS AND TOURISM SECTORS with an ABC of **₱ 300, 000.00**;
