



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **PROVINCIAL MOTOR POOL OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. **2020-0660**; re; **Procurement of Table Tennis Set, by the Provincial Motor Pool Office, New Capitol Site, Tagbilaran City.** with an ABC of **P 78,000.00**;
