WHEREAS, the <u>PROVINCIAL LEGAL OFFICE</u>, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2020-0368</u>; re; <u>Procurement of Conference Table with Chairs, Visitor's Lounge Set, Water Dispenser</u>, <u>Gang Chair</u>, <u>Coffee Maker</u>, <u>Bookshelves</u>, <u>Cups & Saucers & Cutlery Set for use at the Provincial Legal Office</u>, <u>New Capitol Compound</u>, <u>Tagbilaran City</u>, with an ABC of <u>P 124,000.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>SKETCHES & PLOTS</u> & <u>FURNITURES & FIXTURES ENTERPRISES</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>SKETCHES & PLOTS & FURNITURES & FIXTURES ENTERPRISES</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>SKETCHES & PLOTS & FURNITURES & FIXTURES ENTERPRISES</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:
