



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the CANDIJAY COMMUNITY HOSPITAL, CANDIJAY, BOHOL, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. - PHO – 2020 - 125 re: **PROCUREMENT OF VARIOUS JANITORIAL SUPPLIES** with an ABC of P 143,052.39;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **ST. JUDE PRESS MARKETING & SUPPLIES** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **ST. JUDE PRESS MARKETING & SUPPLIES** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **ST. JUDE PRESS MARKETING & SUPPLIES** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:

JUDE PRESS MARKETING & SUPPLIES** as the bidder with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** in the amount P 109,195.00 for the **DELIVERY OF GOODS/SERVICES** under Negotiated Canvass No. – PHO – 2020 - 086; except for item no. 10 having no quotation from the supplier is for re-canvass;
- b.) To recommend award to **ST. JUDE PRESS MARKETING & SUPPLIES** in the amount of ONE HUNDRED NINE THOUSAND ONE HUNDRED NINETY FIVE PESOS AND 65/100 (P 109,195.65) for the delivery of goods under Negotiated Canvass No. – PHO – 2020 – 086;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings
