WHEREAS, the OFFICE OF THE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0661, re; Procurement of Paper & Battery for use at Office of the Governor, New Capitol Compound, Tagbilaran City. with an ABC of P 296,035.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that 3 MSG ENTERPRISES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of 3 MSG ENTERPRISES including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid 3 MSG ENTERPRISES has been found to be ELIGIBLE and its bid, RESPONSIVE;
