WHEREAS, the OFFICE OF THE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0661, re; Procurement of Paper & Battery for use at Office of the Governor, New Capitol Compound, Tagbilaran City. with an ABC of P 296,035.00;
