WHEREAS, the GO-CENTER FOR CULTURE & ARTS DEVELOPMENT, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0903; re; Procurement of Banner (Cloth) and Photo Poster for the use at the Center for Culture & Arts Development, New Capitol Compound, Tagbilaran City. with an ABC of P 324,600.00;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:




