BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

RESOLUTION NO. 20-9812 Series of 2020

WHEREAS, the PROVINCIAL YOUTH & SPORTS DEVELOPMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0348; re; Procurement of Computer Set, Colored Printer, Laminating Machine, Office Filing Cabinet & Projector with Carrying Case, by the Provincial Youth & Sports Development Office, New Capitol Compound, Tagbilaran City. with an ABC of P 130,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>GOLDEN AI TRADING</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **GOLDEN AI TRADING** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **GOLDEN AI TRADING** has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare GOLDEN AI TRADING as the bidder with the LOWEST CALCULATED AND RESPONSIVE BID for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. 2020-0249 except item no. 5;
- b.) To recommend award to <u>GOLDEN AI TRADING</u> for the delivery of goods/services under Negotiated Canvass No. <u>2020-0249</u> in the amount of <u>P 99,998.00</u> except item no. 5;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
