WHEREAS, the **PROVINCIAL YOUTH & SPORTS DEVELOPMENT OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. **2020-0348**; re: **Procurement of Computer Set, Colored Printer, Laminating Machine, Office Filing Cabinet & Projector with Carrying Case**, by the **Provincial Youth & Sports Development Office, New Capitol Compound, Tagbilaran City**, with an ABC of **P 130,000.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **GOLDEN AI TRADING** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:




