



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Single Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the TEODORO B. GALAGAR DISTRICT HOSPITAL, JAGNA, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2020 - 354 re: PROCUREMENT OF 3 in 1 LASER COPIER AND ELECTRIC STAPLER with an ABC of P 239,300.00;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:




