WHEREAS, the **PROVINCIAL GENERAL SERVICES OFFICE**, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0483; re; Procurement of Various I.T Equipment, by the Provincial General Services Office, New Capitol Compound, Tagbilaran City. with an ABC of P 349,900.00;


