RESOLUTION NO. 20-085 Series of 2020

WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2020-0495 re: Completion of Balilihan Plant Nursery Building at Del Carmen Sur, Balilihan, Bohol with an ABC of P 120,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>CLAIRE</u> <u>CONSTRUCTION AND SUPPLY</u> offered the lowest price quotation among the contractors as reflected in the Abstract of Bids Proposals;

WHEREAS, pursuant to Section 53.9 of the Implementing Rules and Regulations of RA 9184, upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>CLAIRE CONSTRUCTION AND SUPPLY</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, <u>CLAIRE CONSTRUCTION AND SUPPLY</u> has been found to be <u>ELIGIBLE</u> and its bid, <u>RESPONSIVE</u>:

- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
