



BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. 2020-0495 re: Completion of Balilihan Plant Nursery Building at Del Carmen Sur, Balilihan, Bohol with an ABC of ₱ 120,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that CLAIRE CONSTRUCTION AND SUPPLY offered the lowest price quotation among the contractors as reflected in the Abstract of Bids Proposals;
