BAC Resolution Declaring LCRQ and Recommending Award

RESOLUTION NO. 20-0859 Series of 2020

WHEREAS, the <u>PROVINCIAL ENGINEER'S OFFICE</u> of the <u>PROVINCIAL GOVERNMENT OF BOHOL</u> made procurement under Purchase Request No. <u>2020-0859</u> re: <u>Construction of Canopies and Supply of Plumbing Materials for the RT-PCR Containerized Laboratory, New Bohol Provincial Capitol Building, Cogon District, Tagbilaran City with an ABC of <u>P 87,170.83</u>;</u>

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>CLAIRE</u> <u>CONSTRUCTION AND SUPPLY</u> offered the lowest price quotation among the contractors as reflected in the Abstract of Bids Proposals;

WHEREAS, pursuant to Section 53.9 of the Implementing Rules and Regulations of RA 9184, upon careful examination, validation and verification of the accreditation and other pertinent documents of CLAIRE CONSTRUCTION AND SUPPLY including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, CLAIRE CONSTRUCTION AND SUPPLY has been found to be **ELIGIBLE** and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- a). To declare <u>CLAIRE CONSTRUCTION AND SUPPLY</u> as the bidder with the <u>LOWEST CALCULATED AND</u> <u>RESPONSIVE BID</u> for the <u>GOODS/SERVICES</u> under Negotiated Canvass No. <u>NC- 2020-0675</u>;
- To recommend award to <u>CLAIRE CONSTRUCTION AND SUPPLY</u> for the goods/services of the aforementioned request in the amount of <u>P 87,050.00</u>;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
