WHEREAS, the OFFICE OF THE PROVINCIAL SOCIAL WELFARE & DEVELOPMENT of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No.2020-0253; re; Procurement of Various Janitorial Supplies, LED Bulb, Shampoo, Soap and Wall Fan for use at the Office of the Provincial Social Welfare & Development-Bohol Crisis Intervention Center, Circumferencial Road, Tagbilaran City. with an ABC of P 89,609.86.
