BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the OFFICE OF THE PROVINCIAL SOCIAL WELFARE & DEVELOPMENT of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0253 re: Procurement of Various Janitorial Supplies, LED Bulb, Shampoo, Soap and Wall Fan for use at the Office of the Provincial Social Welfare & Development- Bohol Crisis Intervention Center, Circumferential Road, Tagbilaran City, with an ABC of P 89,609.86;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that D 18TH HI-WAY MARKETING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;


