WHEREAS, the **GOVERNOR'S OFFICE – CSO** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2020-C-208** re: **PROVISION OF ACCOMMODATION AND MEALS FOR THE ANNUAL STRATEGIC PLANNING 2021** with an ABC of **₱ 125, 000.00**;




