Castillo Sr. Memorial Hospital, Loon, Bohol** in undertaking Procurement Request under **PR No. - PHO - 2020 - 011** re: **PROCUREMENT OF DISINFECTANT, DRAIN MAINTENANCE & HANDS ON LOTION** with an ABC of **P 177,000.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **CHEMTRUST GLOBAL MARKET INC.** offered the lowest price among the suppliers as reflected in the Abstract of Bid Proposals;
