WHEREAS, the **PROVINCIAL LEGAL OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Request No. 2020-0579; re; Procurement of Subdivision Survey of Government Lots for Barter with Affected Private Lots at the New Bohol Airport Construction at Lourdes, Bolod, Tawala & Danao at Panglao, by the Provincial Legal Office, New Capitol Compound, Tagbilaran City. with an ABC of P 593,750.00;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:




