BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL LEGAL OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0579; fe; Procurement of Subdivision Survey of Government Lots for Barter with Affected Private Lots at the New Bohol Airport Construction at Lourdes, Bolod, Tawala & Danao at Panglao, by the Provincial Legal Office, New Capitol Compound, Tagbilaran City. with an ABC of P 593,750.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>LUMUTHANG</u> <u>SURVEYING OFFICE</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>LUMUTHANG SURVEYING OFFICE</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>LUMUTHANG SURVEYING OFFICE</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare <u>LUMUTHANG SURVEYING OFFICE</u> as the bidder with the <u>LOWEST CALCULATED AND RESPONSIVE BID</u> for the <u>DELIVERY OF GOODS/SERVICES</u> under Negotiated Canvass No. <u>2020-0436</u>;
- b.) To recommend award to <u>LUMUTHANG SURVEYING OFFICE</u> for the delivery of goods/services under Negotiated Canvass No. <u>2020-0436 in the amount of P 593,000.00;</u>
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
