BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the <u>PROVINCIAL GENERAL SERVICES OFFICE</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. <u>2020-0483</u>, re; <u>Procurement of Various I.T Equipment, by the Provincial General Services Office, New Capitol Compound, Tagbilaran City.</u> with an ABC of <u>P 349,900.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>B&J COMPUTER</u> <u>SALES AND ELECTRONIC SERVICES INC.</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
