WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 20-066% series of 2020 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the OFFICE OF THE GOVERNOR in undertaking Procurement Request under PR No. 2020-0007 re: Procurement of Office Tables, Office Chairs & Gang Chairs for the use at the LGA CSS Finance & Office of the Governor, New Capitol Site, Tagbilaran City with an ABC of P 79,800.00.
