BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the OFFICE OF THE PROVINCIAL VETERINARIAN of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0871, re; Procurement of Engine Oil, Vehicle Spare Parts & Labor for the Maintenance of Vehicle with Plate No. SEZ - 400 & SEZ - 590, by the Office of the Provincial Veterinarian, New Capitol Compound, Tagbilaran City, with an ABC of P 164,670.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that 200 M AUTO REPAIR SHOP & PARTS offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
