

BAC Recommending Procurement thru Negotiated Method Resulting from the Second Failure of Bidding, Declaring LCRQ and Recommending Award

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 20-0829 series of 2020 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT in undertaking Procurement Request under PR No. 2020-0751 re: Procurement of Labor, Materials & Equipment for the Second Floor Expansion of Tarsier 117 Command Center at Camp Bernido Compound, by the Provincial Disaster Risk Reduction Management Office, New Capitol Site, Tagbilaran City. with an ABC of ₱5,112,588.90;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that ONE GIGATT CORPORATION offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:




