WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2020 - 340 re: PROCUREMENT OF SUPPLIES FOR THE USE OF PHO MAIN FIELD HEALTH SERVICES INFORMATION SYSTEM DATA RECORDING with an ABC of P 139,050.00.

- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings
