

- b.) To recommend award to BYRO PHARMA in the amount of TWO HUNDRED FIFTY SIX THOUSAND SEVEN HUNDRED SEVENTY NINE PESOS AND 58/100 (P 256,779.58) for the delivery of goods under Negotiated Canvass No. - PHO - 2020 - 328;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings


