



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL HUMAN RESOURCE MANAGEMENT AND DEVELOPMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0797; re: Procurement of Gift Certificates (Goods) for Frontliner Awardees in Line with the Celebration of the 120th Civil Service Anniversary, Provincial Human Resource Management and Development Office, New Capitol Site, Tagbilaran City, Bohol with an ABC of P 871,320.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that ISLAND CITY MALL-SUPERMARKET/ ALTURAS SUPERMARKET CORPORATION offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of ISLAND CITY MALL-SUPERMARKET/ ALTURAS SUPERMARKET CORPORATION including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid ISLAND CITY MALL-SUPERMARKET/ ALTURAS SUPERMARKET CORPORATION has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare ISLAND CITY MALL-SUPERMARKET/ ALTURAS SUPERMARKET CORPORATION as the bidder with the LOWEST CALCULATED AND RESPONSIVE BID for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. 2020-0613;
- b.) To recommend award to ISLAND CITY MALL-SUPERMARKET/ ALTURAS SUPERMARKET CORPORATION for the delivery of goods/services under Negotiated Canvass No. 2020-0613 in the amount of P 822,000.00;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
