

WHEREAS, the PROVINCIAL ADMINISTRATOR'S OFFICE - PROVINCIAL PROCUREMENT MANAGEMENT UNIT of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0840; re; Procurement for Bondpapers, Inks & Housekeeping Supplies for the Use, at Provincial Procurement Management Unit New Capitol Compound, Tagbilaran City., with an ABC of P 108,053.20;
