



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL ADMINISTRATOR'S OFFICE - PROVINCIAL PROCUREMENT MANAGEMENT UNIT of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0840; re: Procurement for Bondpapers, Inks & Housekeeping Supplies for the Use, at Provincial Procurement Management Unit, New Capitol Compound, Tagbilaran City., with an ABC of P 108,053.20;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that GOLDEN AI TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:




