

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL INFORMATION & MEDIA RELATIONS, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0577; re; Procurement of Gang Chair, Office Chair, Magazine Rack, Filing Cabinet, Metal Shelving Rack & Soundproofing Foam Sound Absorption Pyramid Studio Treatment Wall Panels, by the Provincial Information & Media Relations, New Capitol Compound, Tagbilaran City, with an ABC of P 153,300.00;
